

Free Breast & Cervical Cancer Screening Camp Organized

AKHNOOR, JAMMU:- Under Project AAROH, a Free Breast and Cervical Cancer Screening Initiative exclusively for women was successfully organized at Tacherwan, Block Akhnoor, Jammu. The initiative was supported by General Insurance Corporation of India (GIC Re) and implemented by Human Organisation For Patronisation of Environment (HOPE). Medical & Health Team Present The camp was attended by Mandeep Kour (FMPHW), Charanjeet Kour (FMPHW), and ASHA workers Naresh Devi, Madhu Devi, and Manju Sadotara, who actively supported the screening, awareness, community mobilization, and smooth conduct of the camp under Project AAROH. Awareness & Medical Guidance A comprehensive awareness session was conducted to sen-



sitize women about breast and cervical cancer, common risk factors, early warning signs, preventive measures, and the importance of regular screening. The health team emphasized the importance of early detection and timely medical consultation and encouraged women to remain aware of their health, undergo regular screening, maintain a healthy lifestyle, and

promptly seek medical advice if they notice any unusual symptoms or changes. The ASHA workers also supported community mobilization and encouraged women to participate in the screening camp and make use of available preventive healthcare services. Camp Outcome The camp helped strengthen awareness among women regarding cancer prevention, early

detection, regular screening, and timely treatment. Beneficiaries received screening services, medical guidance, and important health information. The HOPE team actively supported the successful organization and smooth conduct of the camp under Project AAROH, with the objective of making cancer awareness and screening services accessible to women in the community.

173 Persons with Disabilities Receive 316 Assistive Devices in Sunderbani



Sunderbani, Rajouri, September 17, 2026: A special distribution camp was organised in Sunderbani with the aim of supporting Persons with Disabilities and promoting greater independence in their daily lives. Under the initiative, 173 Persons with Disabilities were identified for assistance, with 316 different aids and assistive

devices identified for distribution. The camp was organised under 'Samarth', a Corporate Social Responsibility initiative of J&K Bank, in collaboration with the Artificial Limbs Manufacturing Corporation of India (ALIMCO), District Administration Rajouri and the Social Welfare Department. The camp

focused on providing suitable assistive devices to beneficiaries according to their assessed requirements, facilitating mobility and supporting greater independence. The 173 beneficiaries were identified following an assessment and registration exercise conducted by ALIMCO in April 2025 in coordination with the Social Welfare Department. The assistive devices identified under the initiative include motorised tricycles, tricycles, wheel-

chairs, cerebral palsy chairs, walking sticks, walkers, crutches, hearing aids, Sugamya Canes, TLM kits, rollers, cushions, artificial limbs and calipers.
