

90 Persons with Disabilities Receive 137 Assistive Devices Under J&K Bank's Samarth Initiative

NEWSHERA/RAJOURI: Jammu & Kashmir Bank, under its Corporate Social Responsibility Initiative Project "Samarth," organised a special distribution camp in Manjakote, Rajouri, to provide free aids and assistive devices to persons with disabilities. A total of 90 beneficiaries from Block Manjakote received 137 assistive devices of different categories, with an estimated value of 77.51 lakh. Thanamandi MLA Muzaffar Iqbal Khan attended the programme as the Chief Guest and distributed the devices among the beneficiaries. The camp was organised by the Artificial Limbs Manufacturing Corporation of India (ALIMCO), Mohali Unit, under the Department of Empowerment of Persons with Disabilities (DEPWD), Ministry of Social Justice and Empowerment, Government of India, in collaboration with the District Administration and Social Welfare Department, Rajouri. The beneficiaries had earlier been assessed during an assessment and registration camp organised by ALIMCO in collaboration with the Social Welfare Department, Rajouri, in April 2025. Based on the assessment, the beneficiaries were provided with assistive devices according to their requirements. The devices distributed included 04 motorised tricycles, 01 tricycle, 31 wheelchairs, 02 CP chairs, 38 walking sticks, 01 walker, 08 crutches, 28 hearing aids, 10 Sugamya canes,

07 TLM kits and 07 artificial limbs/calipers. Speaking on the occasion, MLA Muzaffar Iqbal Khan appreciated the efforts of J&K Bank, ALIMCO, the District Administration and the Social Welfare Department for working together to provide assistance to persons with disabilities at the grassroots level. He emphasised that providing suitable assistive devices can help improve mobility, independence and participation in social and community life. Zahir Ali, Branch Head, J&K Bank Manjakote; Abdul Rahim, District Social Welfare Officer, Rajouri; Nidhi Sharma, Tehsil Social Welfare Officer, Rajouri; Kanika Mehta, JM Marketing, ALIMCO; and Muzammil Bhatt, P&O, ALIMCO, along with officials of the District Administration, J&K Bank, ALIMCO and the Social Welfare Department, were present during the camp. Vinod Sharma, Senior Vice President of the Jammu and Kashmir Disabled Welfare Association, District Rajouri, and social worker, expressed gratitude to the Social Welfare Department Rajouri, ALIMCO team and the District Administration for organising the camp. He said such camps should also be organised in the future so that persons with disabilities can receive necessary aids and assistive devices in a timely manner. The initiative highlighted the coordinated efforts of the concerned departments and J&K Bank towards promoting inclusion, dignity, mobility and empowerment of persons with disabilities.
